### COMPULSORY RAFFLE BOOK LEVY

All the above fees INCLUDE a compulsory \$20 levy for the Australian Central Credit Union Community raffle book.

When your raffle book is sold you return the tickets but **keep the money yourself** as you have already paid for them. In effect this means your fees will end up costing you \$20 less plus you might share in some of the big prizes. Every year an FHFC ticket has won at least one prize.

To be fair only 1 book is issued per family (unless you want more) so this \$20 levy **does NOT apply to fees for a 2nd or 3rd family member**.

Books will be issued on the Family Fun Day when fees are paid. If payment is made online, by mail or after the Family Fun Day the books will be handed out at training by Team Managers or Coaches once the payment is received.

This raffle is a **vital fundraiser** to help cover the day to day costs of running our Club.

# PLAYER REGISTRATION FEE PAYMENT POLICY

## INTRODUCTION

It costs approximately \$100,000 to run a football club each year plus thousands of hours of work provided free of charge by many volunteers. Paying registration fees on time is a small way for players to show their respect to the Club, their team mates and to those volunteers whose efforts allow our players to play football each week.

## PURPOSE OF THIS POLICY

The purpose of this Player Registration Fee Payment Policy is to provide guidelines for the payment of Flagstaff Hill Football Club player registration fees. It also provides guidelines for players experiencing hardship.

## WHO THIS POLICY APPLIES TO

This policy applies to players at the Flagstaff Hill Football Club.

## REGISTRATION FEES

The registration fees for 2012 are as follows or unless otherwise negotiated by the Football Operations Committee in conjunction with the Treasurer:

## PAYMENT DUE DATE

Payment is due in full **by 31 March 2012**. Players who have not paid fees by that date **will be ineligible to play** unless a payment plan has been previously agreed to with the Flagstaff Hill Football Club President, Chairman or Club treasurer.

## OUTSTANDING DEBT

Existing players who possess a debt with the Flagstaff Hill Football Club will not be allowed to register for a new season until the debt is paid in full. A-Grade players who possess a debt with the Flagstaff Hill Football Club will not receive any payments after a match win (instead, the applicable amounts will be deducted from their outstanding debt).

## FINANCIAL ASSISTANCE

Financial assistance requests will be handled confidentially on a case-by-case basis by the Flagstaff Hill Football Club President, Chairman and Treasurer. Players, parents, coaches, support staff and officials are encouraged to present cases in person to any member of the group who will have the final decision on any hardship case.

## PAYMENT PLANS

If a player is deemed to be eligible to enter into a payment plan, the following payment plan will apply.

- ... 25 percent of the total fee due by 31 March 2012.
- ... 25 percent of the total fee due by 30 April 2012.
- ... 25 percent of the total fee due by 31 May 2012.
- ... 25 percent of the total fee due by 30 June 2012.

## ORGANISATIONAL RESPONSIBILITIES

The Flagstaff Hill Football Club will:

- ... Publish, distribute and promote this policy
- ... Not allow any player regardless of personal ability or the ability to field a full side, if registration fees have not been paid by the due date or a payment plan negotiated
- ... Monitor and review this policy annually
